Early Registration Deadline is Approaching!

The early registration deadline is approaching soon! **Register before June 25, 2010, and save \$20 off the individual registration fee!** Registrations received by June 25, 2009 are \$115. After this date, the regular individual registration rate will increase to \$135 (until July 30, 2010). For clubs wishing to register 100%, the 100% club registration deadline is July 30, 2010.

Certification of Delegates and Alternates
