

## Lt. Governor, Lt. Governor-designate and Past Lt. Governor Delegate Status

89th Annual Kiwanis District Convention – San Diego, CA - August 13-15, 2009

### Cal-Nev-Ha District Bylaws - Conventions, Article IX, Sections 8 and 9.

"The delegates and their alternates shall be active, privileged or senior members in good standing of the chartered club they represent, and shall be elected by such club not less than thirty (30) days prior to the date of the annual convention or less than fifteen (15) days prior to the date of any special convention. Their election shall be evidenced by a certificate to the District Secretary duly authenticated by the president and secretary of the club. Should any chartered club fail to so certify the election of its delegates and alternates, then the Committee on Credentials shall have the right to determine the seating of the delegates or alternates for such chartered club. A Lieutenant Governor and/or a Past Lieutenant Governor may represent any one club in their division not otherwise represented by three (3) delegates. The status of the Past Lieutenant Governor as a Past Lieutenant Governor shall be certified by the District Governor or the District Secretary."

"All officers, Past Governors, Secretaries Emeriti and Lt. Governors-designate of the District who are active, senior, or privileged members of a Kiwanis club of the District shall be delegates-at-large to all District conventions."
