## District Life Member Status

**District Life Member Status** provides a unique opportunity for recognizing Kiwanians who qualify for special recognition. Individuals who achieve **District Life Member Status** are those who perpetuate the Objects and Objectives of Kiwanis International.

An application for **District Life Member Status** initiated by a club or an individual is subject to the approval of the club Board of Directors and must be signed by the president or secretary of the club. District and division applications must be signed by the Governor, District Secretary or Lt. Governor.

Only a limited number may achieve **District Life Member Status** in any one administrative year. The District Board of Trustees (as set forth in District Bylaws) shall determine the total number to be issued each year.

A club may apply for **District Life Member Status** to honor its president or any other club member. A family or friends may apply through a club. A division may apply to honor its Lieutenant Governor or a Past Lieutenant Governor. A region may apply to honor its District Trustee. The District may apply to honor a District Officer, past or present. It is recognized that there may be exceptional situations.

The cost of **District Life Member Status** is a one-time fee of \$532.50 between October 1, 2009 and September 30, 2010 (15 times annual dues) payable upon application. **District Life Member Status** is achieved and the recognition mementos are forwarded when payment is received.

Once **District Life Member Status** has been achieved, the member's club will never again be required to pay District dues for that member. **District Life Member Status** has no effect, however, on payment of club and International dues or the subscription to the Cal-Nev-Ha Magazine.

**IMPORTANT:** Applications must be made in the name of the individual, not in the name of the office. Payment will be accepted only in the name of the person who is to achieve **District Life Member Status**.
